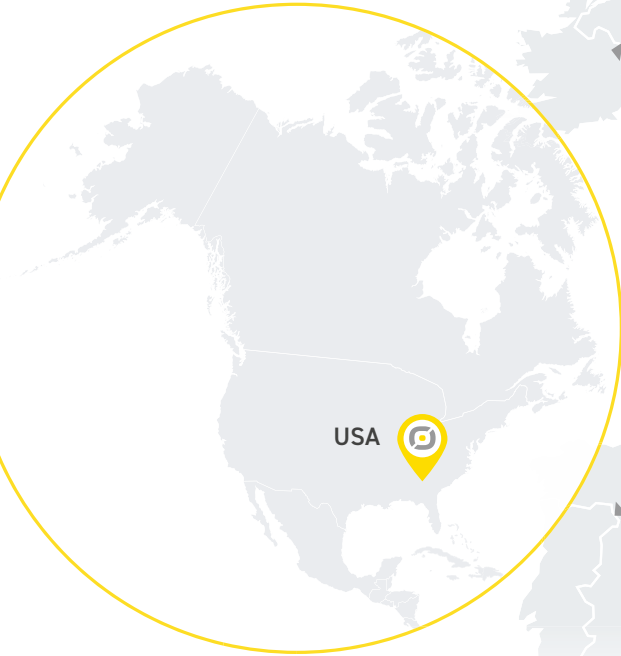

## HAZARDOUS MATERIALS SAFETY CHECKLIST

- 01 Implement a written policy on hazard management, including Material Safety Data Sheets (MSDS), labeling, and training.
- 02 Train all employees on working with hazardous materials — and document that training. Training should include: understanding the chemicals workers may be exposed to; how to read / understand MSDS and chemical labels; how to avoid exposure; and what to do in the event of exposure.
- 03 Maintain a continually updated list of hazardous materials in the warehouse, and implement a system to ensure that every incoming chemical is accompanied by a MSDS.
- 04 Ensure that all containers with hazardous materials are properly labeled with the material's name, manufacturer's name and address, and appropriate hazard warnings.
- 05 Ensure that all chemicals are stored — and disposed of — in accordance with the manufacturer's recommendations and all applicable fire codes.
- 06 Provide proper personal protective equipment (PPE) to employees who handle chemicals; provide appropriate cleanup kits for hazmat spills; and provide training on how to react to spills.
- 07 Provide all outside contractors with a complete list of chemical products, hazards, and precautions.
- 08 Review your hazard management policies and procedures regularly, to maintain the effectiveness of your hazmat safety program.
